

Bid Document including the Application Form and detailed Terms & Conditions can be obtained from Estate Office, Kala Shah Kaku Campus during office hours (8:00 am to 3:30 pm) on same days of advertisement on PPRA's website or in the newspapers on production of Receipt of **Rs.1,000/- for Cafeteria and Rs.500/- for General Store** after depositing in University Main Account No. 553-33 on Bank Challan at HBL Engineering University Branch, Lahore or HBL Booth at Kala Shah Kaku Campus.

Interested bidders will have to submit the technical bid and financial bids on the basis of **Single Stage Two Envelops for Cafeteria and Single Stage One Envelop for General Store** according to the Punjab Procurement Rules, 2014. The last date for submission of bids will be Monday, the 25th April, 2016 up till 11:00 AM and late submission will not be accepted/entertained. The technical bids for Cafeteria and Financial bids for General Store will be opened on same day at 11:45 AM in **Conference Room adjacent to Vice-Chancellors' Office at UET, Lahore** in the presence of available bidders or their authorized agents.

Note:

- 1) The envelops for Cafeteria must be marked in bold letters as **"Technical Bid"** and **"Financial Bid"**.
- 2) The successful bidder will be responsible for payment of Taxes of all types imposed by the Government in addition to monthly rent through University.
- 3) Interested bidders/tenderers will have to submit the 5% Earnest Money of estimated monthly rent to be calculated on the basis of 12 months in the shape of CDR only in favour of "The Treasurer, University of Engineering and Technology, Lahore" along with the tender proposal(s).
- 4) Bids/tenders shall be governed by Punjab Procurement Rules, 2014.
- 5) No telegraphic/emailed/faxed or incomplete tender/bid proposal will be accepted.
