Sealed Bids on the basis of **Single Stage Two Envelopes** (PPRA Rules 2014) are invited from the Firms registered with Park & Horticulture Authority (PHA) and having valid registration of Pakistan Engineering Council (PEC) on the following terms and conditions:

1. The Bids will be received on **August 30, 2018** before **11:00 AM** in the **Project Director's Office Located at University of Engg. & Tech. Narowal Campus, Adda Siraj, Narowal Muridke Road, Narowal** and Technical will be opened on same day at **11:30 AM** in the presence of Bid Opening Committee & the Bidders or their authorized agents, who care to be present.
2. No Bid will be accepted after closing time on the date of the receipt of the bids.
3. No telegraphic bid or bid by post will be entertained.
4. Conditional bids and bids without earnest money at 2% of the Estimated Cost in shape of CDR / Bank Draft /Cashier's Cheque of any scheduled Bank of Pakistan will not be accepted.
5. Detailed particulars of work can be seen in the office of the under signed on any working day during the office hours.
6. For getting the bid documents, fee must be deposited in Main Account (UET) of Habib Bank Limited (HBL), UET Branch G.T Road, Lahore.
7. The Procuring Agency may reject all bids at any time prior to the acceptance of a bid. However, the Procuring Agency will upon request communicate to the bidder the ground for its rejection but will not be required to justify the ground (as per PPRA Rules).
8. Bid documents can be obtained from office of Project Director Located at UET Narowal Campus, Adda Siraj, Narowal Muridke Road, Narowal during office hours on payment of the prescribed bid fee, which is non-refundable.
9. No bid will be issued on the date of the receipt of the bidders.
10. The bid from a Firm / Company participating as a joint venture should be accompanied with power of attorney on proper judicial papers.
11. The Firm must have the valid registration with "Pakistan Engineering Council".
